WKQZ'S "FATHER'S DAY GIVEAWAY" CONTEST OFFICIAL RULES

The Station will conduct the **WKQZ** "Father's Day Giveaway" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age twenty-one (21) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 6 months and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 6 months Void where prohibited by law. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. **Contest Period.** The Contest entry period will begin at 6:00am ET on June 5, 2023 and will run through 9:00am ET on June 16, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** There is (1) way to enter this Contest:

<u>On-Air</u>: Listen to the Station weekdays between 6:00am ET – 9:59am ET ("Morning Drive"), 10:00am ET – 1:59pm ET ("Midday"), and 3:00pm – 5:59pm ET ("PM Drive") during the Contest Period. Station will play one (1) cue to call during Morning Drive, one (1) cue to call during Midday, and one (1) cue to call during PM Drive. When the Station plays the "cue-to-call" sounder, listeners must call the Station at 1-800-976-2593. Caller nine (9) to the Station, as determined by the Station in its sole discretion, will be qualified for the Grand Prize drawing on February 10, 2023 for the opportunity to win the Grand Prize (each a "Qualifier"). *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

There will be a total of twenty-seven (28) Qualifiers in this Contest. Each Qualifier will be notified at the time of the call and will be deemed a Qualifier subject to verification of eligibility and compliance with the terms of these rules.

4. **Winner Selection.** All Qualifiers will be entered into a random drawing from all the valid Qualifiers, One qualifier will be drawn at random and will be deemed the "Grand Prize Winner".

The winner will be awarded the prize subject to verification of eligibility and compliance with the terms of these rules. Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
