## Z93'S "TEXT TO WIN WEEKEND" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WKQZ ("Station"), owned and operated by Cumulus Radio LLC, 1740 Champagne Dr, Saginaw, MI 48604, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **Z93's "Text to Win Weekend"** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the six (6) months. Void where prohibited by law. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. - 2. **Contest Period.** The Contest will begin at **6:00am ET on February 9, 2024** and will run through **11:59pm ET on February 11, 2024** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** To enter:
  - (i) <u>Text</u>: Listen during the Contest Period for the keyword. Send a text message with the keyword "MAGIC" spelled correctly to 1-800-9-ROCK-93 during the Contest Period. All entries must be received by 11:59pm ET on February 11, 2024 to be eligible to win. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit nine thousand nine hundred ninety nine (9,999) entries per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.
- 4. **Winner Selection.** On or about 10:00am ET on February 12, 2024, Station will select one (1) entry for a Prize (as defined below) in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrants will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the

Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.

- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
